What an eventful year it has been. Early in 2019 we began to fully renovate our 20 year old Children's Health Centre and decades old Surgical Centre at Surrey Memorial Hospital.

The Children's Health Centre is the regional pediatric centre serving 43% of the province's children. This transformation will see more clinical rooms added, a bright and renewed space for children receiving cancer treatments in the Joseph Chung Pediatric Oncology Unit, and Surrey's first pediatric pre and post surgical unit. Surrey Memorial's Surgical Centre is Fraser Health's busiest surgical centre, providing over 21,000 surgeries each year. All ten operating rooms are being completely renovated with the latest innovations, which will help attract and retain the best surgical talent to Surrey.

With incredible donor support, we installed Fraser Health's first 3T MRI and first Tomosynthesis machines at the Jim Pattison Outpatient Care and Surgery Centre. We also launched Fraser Health's first Mobile Health Clinic in partnership with TELUS Health For Good.



MESSAGE **FROM OUR LEADERS**

Our 2020 Celebration of Care Gala was a tremendous success. 680 quests joined us for a night of Hollywood style glamour, and raised \$1.3 million to purchase a Spinal Navigation System for our Surgery Centre.

Then COVID-19 struck. Surrey Memorial Hospital, with its state-of-the-art ER and Critical Care Tower, became an important asset in BC's campaign to prevent viral spread and reduce human suffering.

During phase one of the pandemic, our Foundation guickly transitioned to actively support our 8,000 health care workers on the front line. We worked with the community to supply meals and snacks, life-saving equipment and investments in research. We were able to pivot our focus quickly and effectively due to the generosity of our community.

From the moment COVID-19 hit, residents and businesses in Surrey showed incredible resilience and innovation providing everything from PPE to food. The Foundation is fortunate to ride the wave of Surrey's collective generosity and advocacy.



SURREY MEMORIAL HOSPITAL CELEBRATES 60 YEARS







In 1949, community fundraising and lobbying efforts lead by the Ladies Auxiliary, allowed for the land purchase for Surrey Memorial Hospital: construction began in 1957. The hospital opened its doors on January 31, 1959, with the first patient admitted just five days later. In 1959, there were 687 babies welcomed into the world at Surrey Memorial Hospital; in 2020 we are welcoming over 5,000 newborns each year.

Surrey Memorial Hospital opened as a 103 bed general hospital, offering basic services and units such as Medicine, Surgery, Maternity, and Pediatrics. As Surrey's population grew, demands on the hospital increased. By 1968 expansion plans were already in place for the East and West wings which would add acute care and psychiatric beds.

Over the last sixty years, Surrey Memorial Hospital has expanded and continues to grow to meet the needs of Surrey's diverse and rapidly growing population.

Surrey Hospitals Foundation celebrated this milestone by inviting the public to participate in Surrey's Baby Wall of Fame. Over 500 entries were received of baby photos for those born at Surrey Memorial Hospital, including one from 1959!

OUR EARLY COVID-19 **RESPONSE**







When the COVID-19 pandemic hit BC, Surrey Memorial Hospital guickly became one of the busiest COVID-19 treatment centres in Canada. In turn. Surrey Hospitals Foundation's role as the bridge between the community and its health care facilities soon became a critical part to what would become a united stance against the pandemic.

In response to the sudden outpouring of donations and inquiries of how to help, Surrey Hospitals Foundation created the COVID-19 Response Fund on March 20, 2020. Donations from near and far started to come in from new and existing hospital supporters.

Many achievements have, and will continue to be made due to the community's support of the COVID-19 Response Fund. We went to work immediately creating processes for receiving in-kind gifts such as warming jackets for nurses testing patients outside of the Emergency Department, and generous donations of meals and snacks for our frontline health care workers. We have and continue to work closely with hospital administration to determine emerging needs related to new equipment purchases and local research studies.

We are thankful and proud to be a part of this kind-hearted community. Perhaps the best gift we have received during this time is the gift of knowing that, together, we will continue to be an unstoppable force for life-changing health care.

CHILDREN'S HEALTH CENTRE CAMPAIGN







The Children's Health Centre in Surrey is one of the busiest and most respected in the province. It is the only facility in the region dedicated to children's health and pediatric emergencies. Since it was built in 2001, Surrey's population has increased over 50%, yet the footprint of the Centre has not. We have been working with the community to raise \$6 million toward this project; we are less than \$1 million from our goal.

Renovations in the Children's Health Centre commenced in early 2019. Plans for a renewed, family-friendly space with a whimsical woodland theme are coming to fruition. A beautiful, bright, renewed space for children receiving cancer treatment is now complete. This unit is named in memory of Joseph Chung, with thanks to a \$1 million gift from the Chung family. A dedicated pre- and post- surgery unit for children is also underway, offering children a calm and guiet space to prepare for and recover from surgery.

Phase 3 of this renewal project is underway. It will increase clinical rooms for outpatient clinics and expand services in others. A comfortable waiting area is being created for families. Our Foundation is excited to be working with Microsoft on an augmented reality system that will guide children and families through their stay in the Children's Health Centre, providing education and comfort.

MEET TAMMY THOMSON


In April of 2019, Tammy Thomson was a young, active, healthy 30 year old woman; a wife and mother of two small children. As a kindergarten teacher she was finishing up the school year with her existing class and already planning for the next school year. It was to be an exciting year ahead, as Tammy's own daughter would be joining her class as a student – a dream come true for them both.

During a routine breast exam at home, Tammy noted an abnormality. Though quite assured it wouldn't be anything serious due to her age and overall good health, Tammy prudently booked an appointment with her family doctor to have it checked out.

Tammy's family doctor sent her for a mammogram, an effective screening test to examine and diagnose breast tissue health and to detect breast cancer. No abnormalities were identified on the mammogram, so Tammy was sent for further test investigations over the next two months - 3 more mammograms, 2 biopsies and a galactogram. One of the biopsies showed a pea sized lump, which was determined to be benign. Despite these promising results, Tammy had a strong gut feeling that something was not right. She decided to seek one more opinion.

Tammy was referred by a friend to the specialized Breast Health Clinic at Jim Pattison Outpatient Care and Surgery Centre in Surrey. Specifically, she was encouraged to book an appointment with Dr. Rhonda Janzen, a surgeon at the Breast Health Clinic.

PATIENT STORY



A challenge for existing screening technology can sometimes be identifying abnormalities in patients with dense breast tissue. Tammy Thomson was one of these patients. Though traditional digital mammography remains one of the most advanced tools available for detecting breast cancer, a new 3D mammography called Tomosynthesis provides greater detection of abnormalities hidden in dense breast tissue.

With incredible donor support, Surrey Hospitals Foundation was able to purchase Tomosynthesis for Surrey's Breast Health Clinic earlier this year. The funding was initiated by Tammy Ritchie of the Ritchie Foundation, one of the Holiday Home Tour for Hope team members. The Tour also supported the Tomosynthesis purchase.

This technology will increase early detection of breast cancer, and provide greater accuracy for determining the exact size, shape, and location of abnormalities. Thanks to our donors, patients in situations such as Tammy's will receive more accurate test results in a timely manner.

Tammy Thomson is doing well. She is undergoing reconstructive surgery in October 2020. "How serendipitous," she says, "that I will be having surgery during Breast Cancer Awareness month, exactly one year after my double mastectomy. I am so incredibly thankful for Dr. Janzen, and for the donors who made it possible to bring in this new technology that will help many, many women."



SURGERY **CAMPAIGN**

Surrey Hospitals Foundation has partnered with Fraser Health to renovate and renew 10 operating rooms at Surrey Memorial Hospital. We have committed \$10 million toward this project. The renovation will bring more of the very best and most innovative technology to Surrey, which will help to attract and retain top surgical talent from across the globe. Surrey Memorial Hospital is home to the region's busiest surgical centre, where 70 surgeons practice 10 specialties.

Three of the 10 renewed operating rooms are now complete.

During the 2020 Celebration of Care Gala, \$1.3 million was raised to purchase a spinal navigation system for the surgical centre. One of our newest orthopedic surgeons, Dr. Melissa Nadeau, is currently trialing this equipment. This system not only enables surgeons to be as precise as possible while performing back surgeries, it will also allow our talented surgical team to perform specialty back surgeries right here in Surrey, instead of having to send our residents to Vancouver.

On February 22nd, 680 of Surrey's business leaders and medical luminaries joined us for the 5th Annual Celebration of Care Gala. Guests were treated to an evening of celebrity-style glamour at what was Surrey's largest and most successful event of the season. Surrey Hospitals Foundation was proud to support many exceptional equipment purchases and hospital programs in 2019-2020.


Here are three of the many highlights:

- 1. In May 2019, Fraser Health revealed its first 3Tesla MRI. This powerful diagnostic tool delivers twice the field strength of the existing 1.5MT MRIs currently used throughout Fraser Health. It is one of only three in the province. Approximately ten per cent of this project was donated by Jeff Wubs, founder of Westland Insurance Group Ltd., via a donation to Surrey Hospitals Foundation.
- 2. Our Foundation is proud to help foster Music Therapy at Surrey Memorial Hospital as a way to help youth struggling with mental illnesses to learn life skills, build resilience, and re-integrate them into their communities. Music Therapy is currently offered in the Child and Adolescent Psychiatric Stabilization Unit, Adolescent Psychiatry Unit, Adolescent Day Treatment Program, and the Neonatal Intensive Care Unit.

Music is a language all youth respond to. The Music Therapy Program encourages them to play instruments to develop harmonies together; to analyze lyrics of current hit songs as well as write lyrics together, giving them opportunities to connect words to feelings and thoughts that they could not seem to access previously.

3. Surrey Memorial Hospital is the first and currently only hospital in BC to offer a revolutionary treatment to help patients suffering from achalasia, a disorder of the sphincter muscle separating the esophagus and stomach. Patients with achalasia experience choking, heartburn and pain with each meal. With thanks to our donors, Surrey Hospitals Foundation was able to purchase a Per Oral Endoscopic Myotomy (POEM) for our surgical team.

Dr. Wen of Surrey Memorial Hospital is shown here with Keith Currah, who was able to enjoy eating again after surgery with the POEM equipment. Keith now lives a life without pain and anxiety at every bite of food.




TOTAL REVENUE & EXPENSES OVER THE LAST 5 YEARS

MINI MED SCHOOL

On Saturday, November 30, 2019 Surrey Hospitals Foundation hosted the first-ever Mini Med School at Surrey Memorial Hospital.

Eighty students in grades 10-12 from local Surrey high schools attended the event, which had a wait list of 100.

Emceed by Dr. Raymond Dong, President, Medical Staff Association, SMH and JPOCSC, the event was hosted in the UBC School of Medicine lecture theatre and the simulation lab at Surrey Memorial. The day began with an inspiring talk with Dr. Ahmad Ashrafi, a renowned thoracic surgeon, who shared his inspiring journey into medicine and lifelong learning.

Mini Med School gave students an opportunity to explore a variety of medical specialties in small-group workshops with physicians and technicians. They experienced hands-on learning simulations such as removing a grape skin with a pin under the guidance of a retinal surgeon, and watching their output efforts on an overhead screen during a CPR simulation in the lab. The first cohort of Mini Med School students were fortunate enough to learn from some of Surrey's top specialists.





REDFM GURPURAB RADIOTHON

The 13th Annual 93.1 RedFM Gurpurab Radiothon was held on the occasion of the 550th anniversary of Guru Nanak's birth; the founder of the Sikh faith. The goal was to raise \$550,000 to update the Mata Tripta Family Birthing Unit, named by the community after a successful Gurpurab Radiothon in 2012.

RedFM's listeners and community rallied together on this special occasion and raised over \$750,000 for this important upgrade to this busy maternity unit at Surrey Memorial Hospital.

Funds raised from this event will support the purchase of 2 infant resuscitation warmers with required accessories, 3 Bili Meters with photo therapy lights and blankets to treat and cure jaundice; 10 specialty devices to help women during labour; milk warmers; breast pumps, and; a variety of other pieces of equipment that will ensure each room is fully outfitted for delivery and care of newborn babies.





FRASER HEALTH MOBILE HEALTH **CLINIC POWERED BY TELUS**

Individuals in Surrey will now have easier access to immunizations, dental care and sexual health services with the launch of the Fraser Health Mobile Health Clinic powered by TELUS.

Already active in Vancouver, Victoria, and across Canada, this program helps to remove many of the barriers that marginalized Canadians face in receiving medical care.




